### Narrative

The district is requesting proposals for Managed Internet Broadband Services, Leased Wireless Network Equipment, District Owned Wireless Network Equipment and the Addition of Network Equipment required for both the existing campus and the new annex building. Vendors may submit proposals for one or multiple solutions, and the district will evaluate all eligible options.

#### Scope of Work

The district is seeking bids for three specific project areas:

1. Upgrade of the Existing Wireless Network by replacing the current wireless access points and switches districtwide and replacing switches must be stackable with the districts current switches and support dual uplinks to the core. The existing network includes 69 wireless access points (62 indoor, 3 gymnasium, 4 outdoor).
2. Expansion of the Wireless Network in the Newly Constructed Annex Building by installing a minimum of 20 new wireless access points, including 5 high capacity APs for gym/multifunction spaces and providing all cabling, components, and installation needed for full wireless coverage.
3. Addition of Network Equipment in the Annex Building by providing new network switches, SFP modules, UPS units, and structured cabling. All UPS devices must be 2000VA, network managed, and lithium-ion, with no required battery replacement.

#### Additional Requirements:

- \*A mandatory site walkthrough is required for any vendor submitting a bid. Bids from vendors who do not participate in the walkthrough will be disqualified.
- \*All quotes must include all necessary cabling materials, components, installation, labor, and related costs to complete the project.
- \*All equipment must be new and include a manufacturer warranty. Used or refurbished equipment will not be considered.
- \*If different equipment is proposed, vendors must provide documentation demonstrating equivalency, or the proposal will not be considered.
- \*Installation costs must be listed separately from hardware costs.
- \*Vendors must provide their SPIN and must document that they are an authorized reseller of the equipment being proposed.

\*Instate or local vendors are preferred, as is previous successful experience with the district.  
\*SPAM, robotic, or nonresponsive submissions will be disqualified.  
\*The district reserves the right to reject any bids received on or after the Allowable Contract Date listed on the Form 470.
