## **Narrative**

The Trimble County Board of Education (BOE) seeks proposals from qualified service providers for a Leased Lit Fiber Wide Area Network (WAN) connection (or functionally equivalent service) to establish a dedicated, high-speed, point-to-point data transmission link between two district locations.

This service is requested as a fully managed and maintained solution, where the selected Service Provider is responsible for the design, construction (if necessary), equipment (including terminating electronics), lighting, maintenance, management, and monitoring of the fiber connection. The service provider will own and operate all necessary infrastructure and equipment.

The connection endpoints are:

District Data Center Hub (A-End): Trimble County Jr/Sr High School, 1029 HWY 421N, Bedford, KY 40006

Remote School Location (Z-End): Milton Elementary School, 9245 HWY 421 N, Milton, KY 40045

The requested service is for transport only (no Internet access included) and must be a symmetrical connection, providing the same bandwidth capacity in both the upload and download directions.

### **Contract Term and Bidding Requirements**

The Trimble County BOE requires a contract for a fixed sixty (60) month term, beginning on July 1 of the funding year.

All proposals must be received by 11:59 PM EST on January 23, 2026. Bids received after this date will not be considered.

Bidders must provide separate, distinct, and complete pricing for all three requested speeds. Partial bids for some but not all speed options will be considered, but a complete bid for a specific speed must be all-inclusive.

### **Requested Bandwidth Options:**

1 Gbps (Symmetrical) | Leased Lit Fiber/Equivalent WAN | 60 Month Term

2 Gbps (Symmetrical) | Leased Lit Fiber/Equivalent WAN | 60 Month Term

5 Gbps (Symmetrical) | Leased Lit Fiber/Equivalent WAN | 60 Month Term

All proposals must adhere to the following pricing structure:

Pricing must be clearly broken down into Monthly Recurring Costs (MRC), including:

Service Fee (Pre-discount cost of eligible service)

Estimated Taxes, Fees, and Surcharges (Non-eligible charges)

Any one-time or Special Construction charges (if applicable) must be explicitly listed and priced separately.

### **Mandatory Bidder and Contract Clauses**

All respondents must meet the following mandatory requirements:

Possess an active and valid Service Provider Identification Number (SPIN) with the Federal E-rate Program.

Agree to the terms of the requested 60-month contract term.

All resulting contracts must include the following mandatory contract termination clause:

Contract Termination Clause: Should the Applicant's request for E-rate funding for any year of the contract term be denied or reduced by the Universal Service Administrative Company (USAC) and/or the Federal Communications Commission (FCC) to a level that the Applicant deems unsatisfactory or financially unfeasible, the Applicant shall have the option to terminate the contract without penalty or charge upon written notice to the Service Provider.

The Trimble County BOE reserves the right to select the most cost-effective solution with price being the primary factor, as required by E-rate regulations.
