<p><b>Bid Request</b></p> <p>1) Seeking MIBS monthly maintenance services for our existing network and network security.</p> <p>2) Services should include management, and monitoring of eligible broadband internal connection components, including actual tasks that directly support and are necessary to maintain effective broadband connectivity within libraries. Includes, but not limited to: monitor all eligible hardware and software, reporting on overall health and stability of system(s), services necessary to manage and repair the LAN/WLAN network, such as diagnostic services, installation, activation, and initial configuration of eligible components, basic technical support, repair and/or replacement of eligible hardware included in Appendix A MIBS Supported Equipment. It should include configuration changes, software upgrades and patches, including bug fixes and security patches.</p> <p>3) Vendors must also be willing to bid an hourly rate for repair/replacement of eligible hardware and invoice us based on actual time and cost spent repairing/replacing eligible hardware at our Honesdale location. Bidders who have not worked with us on prior Erate projects must provide a current FCC Form 473 (SPAC) or provide evidence that they have filed for same.

The vendor/bidders primary business address must be within a 50 mile radius of our Honesdale library location at 1406 North Main Street, Honesdale, PA 18431 as determined by Google Maps.

Bidders must have prior experience installing and maintaining Arista Edge Threat NG Firewall equipment and licenses. References for prior installations of Arista Edge Threat NG Firewall will be required.

Bidders must have prior experience with the administration and configuration of Arista Edge Threat NG Firewall software.

References for prior installations of Arista Edge Threat NG Firewall software will be required on the final page of the Appendix B spreadsheet.

#### **Bidder Questions**

Bidder questions will be accepted through December 29, 2025 at 5:00pm Eastern Time.

All questions will be answered and posted to the Erate system on USAC by January 5, 2026 at 5:00pm Eastern Time.

#### **Bid Disqualifications**

All bids are due by the close of business on the Allowable Contract Date (ACD). We reserve the right to accept or reject late-submitted bids/proposals. However, points may be taken away from "Meeting Overall Needs," evaluation criteria if we decide to accept a late-submitted bid.

Bids not submitted on the Appendix B MIBS Request Bid Sheet spreadsheet will be disqualified.

Bids from vendors who do not have an Erate Service Provider Identification Number already established will be disqualified.

Bidders who have not provided a current FCC Form 473 (SPAC) will be disqualified.

If the bidders primary business address is not within a 50 mile radius of our Honesdale library location at 1406 North Main Street, Honesdale, PA 18431 as determined by Google Maps, their bid will be disqualified.

If the bidder does not have prior experience installing and maintaining Arista Edge Threat NG Firewall equipment and licensing, their bid will be disqualified

Proposals that do not meet minimum bid requirements, do not specifically address the services requested, are generic in nature or otherwise do not meet the requirements contained in this Request For Proposal and associated specifications will be considered non-responsive. Non-responsive bids will be disqualified.

SPAM and/or robotic responses will not be considered valid bid responses and will be disqualified from consideration.
