The service provider should evaluate the needs of district and provide a complete quote including equipment to meet the needs of Franklin Community School Corporation. Applicable items should include all related software and hardware components that enable the functionality of the equipment (including any necessary mounting brackets, multi-year licenses/software, and basic maintenance). Vendors shall specify all fees, shipping charges, taxes, surcharges and contingency fees for eligible equipment. Vendors may submit alternative equipment as long as the equipment is an equivalent make and model, serves a similar functionality, and is compatible with the current network. Include in your proposal, any connectors and / or related components necessary for proper function of the requested items. The District reserves the right to adjust quantities prior to purchasing to meet the Districts needs.

All prospective vendors must complete a district walkthrough/onsite survey in order to be eligible to submit a proposal. During the walkthrough all detailed questions will be answered. Proposals from vendors who do not complete the walkthrough/onsite survey WILL NOT be considered. The walkthrough will occur by scheduled appointment during the week of February 17, 2020. We will consider multi-year contracts with or without voluntary extensions. All cost proposals must reflect the LCP (Lowest Corresponding Price), GSA pricing, and any available governmental unit discounts including existing state purchasing agreements or contracts when applicable. Any proposal referencing an existing state purchasing agreement or contract must include that information in the proposal. Bid prices must be complete for the services proposed and shall include all associated costs, even if the amounts are estimates based upon current applicable taxes, surcharges, or fees.

Proposal shall provide a separate section listing for each building with all costs associated with the proposal for that building.

Each line item on proposal should clearly list Quantity, Manufacturer, Part Number, Description, Unit Price, and Extended Price. Proposals MUST separate eligible and ineligible services by line item for all services to which service provider responds.
