Marcus Whitman Middle School

MWMS needs a new IDF (#4) and new network cabling from the CTE STEM lab to IDF 2.

The new IDF 4 will need these items supplied and installed:

o A fire rated and painted back board

- o A 12U wall rack (similar to CUBE-IT 11900-x24 Tempered Glass front door 24h x 24w x 24d)
- o Grounding and bonding of the rack
- o Extend power to the rack in a 5-20r quad.
- o 4 core to get from the first floor to the second floor
- o A 12 strand Corning multi-mode OM4 50 micron fiber run approx. 350-400terminated with LC connectors from the IDF2 closet to the location of the new IDF 4 closet that will support 10GB ethernet.
- o The IDF2 rack will need some fiber panel consolidation to make space for the new IDF4 fiber terminations. The CTE STEM lab will need:
- o 48 white CommScope Cat6 cables run from a CommScope Cat6 48-port patch panel in the lab to IDF2 to a CommScope Cat6 48-port patch panel.
- o In IDF2, there are 17 Cat6 cables terminated in a Belden patch panel that will need to be relocated and re-terminated on AMP jacks in an existing AMP Cat6 patch panel to make space for the additional 48 port Cat6 CommScope patch panel in the bullet point above.

John Sedgwick Middle School

JSMS needs a new IDF (#4) in the current CTE STEM lab closet. The existing rack and cabling for the CTE STEM lab will be used

The new IDF 4 will need these items supplied and installed:

- o Grounding and bonding of the rack
- o 4 core to get from the first floor to the second floor
- o A 12 strand Corning multi-mode OM4 50 micron fiber run approx. 350-400 terminated with LC connectors from the IDF2 closet to the location of the new IDF 4 closet that will support 10GB ethernet.
- o The IDF2 rack may need some fiber panel consolidation to make space for the new IDF4 fiber terminations.

At SCES in IDF2, we need to replace the current 6U wall rack with a new 12U wall rack in a very tight space.

The IDF 2 will need these items supplied and installed:

- o A fire rated and painted back board (As needed)
- o A 12U wall rack (similar to CUBE-IT 11900-x24 Tempered Glass front door 24h x 24w x 24d)
- o Grounding and bonding of the rack (As needed)
- o Move the existing fiber and coper patch panels and cabling to the new rack.
