Narrative

The applicant is seeking the following Category One (C1) scope of work:

- Speed: a baseline of 1-gigabit symmetrical service under a multi year agreement, fiber [referred].
- Contract: The contract must be multi-year in nature at either 2,3,4,or 5 years in term. The pricing for the baseline and for all optional speeds up to 5-gigabits must be locked-in for the selected contract term, such that the school may elect to upgrade the speed and the associated pricing for same within the contract term and the discounts will follow the upgraded speed, all under a service substitution.
- Fiber is preferred.

The contract must state the Monthly Recurring Charges (MRC) pricing and any Non-Recurring Charges.

The MRC must be locked-in across the term of the contract, by proposed speed available, again, between Baseline speed of 1-gigabit symmetrical service, up to 5-gigabits maximum - in whatever megabit increments are available

- In other words, all bids must include contract documentation for acceptance, and the contract must include a speed/bandwidth range in accordance with a baseline and a maximum being requested, in whatever increments are available from the bidder, up to the maximum requested, and upgradeable in-place within the term of the agreement.
- All solutions should include installation and all configuration costs (if needed), a method to report outages, and receive basic technical support without additional service fees, and a service level agreement
- Please note that although fiber is the preferred solution, we are willing to consider solutions based on alternative technologies, as long as the solution allows for scalability and reliability equivalent to the preferred solution
- .- Bids must include all eligible and any ineligible NRC (Non-Recurring Costs) and MRC (Monthly Recurring Costs) costs separately, so applicant can evaluate all bids properly and fairly.
