Approximately 9 Cisco C9105AX WAP or equivalent, including applicable licensing, mounting, installation, and adoption as needed. 2.) Approximately 1 Cisco CBS350 10-Port Gigabit POE+ Switch or equivalent, including applicable licensing, mounting, installation, and adoption as needed. 3.) Approximately 3 drops of Cat6 cabling (approximately 600ft). 4.) Approximately 4 Patch cables, 2 "1Ft" and 2 "3Ft".

5.) The school is seeking Managed Internal Broadband Services (MIBS) for the new approximately 9 Cisco C9105AX and 1 Cisco CBS350 Switch or equivalents under a leased equipment arrangement.
