We are seeking bids for a complete internal network hardware refresh at the Coshocton High School Annex building located at 201 S. Water St., Coshocton, OH 43812.

This project consists of a full hardware swap of existing network equipment to support reliable, high-capacity wireless and wired connectivity throughout the facility.

The requested Category 2 services include:

-20 Wireless Access Points

Must support current Wi-Fi standards suitable for a K-12 educational environment

-Cloud or controller-based management preferred

-Three (3) Multigig Network Switches

Must support PoE+ (or higher as required to power access points)

Layer 2 or Layer 3 capability appropriate for school network infrastructure

-Three (3) Uninterruptible Power Supply (UPS) units

Sized appropriately to support proposed switches and associated network equipment

-One (1) Wall-mounted network rack

Properly sized to house switches and related networking equipment

Additional Requirements

Equipment must be new and eligible under E-Rate Category 2 guidelines.

Installation, configuration, and basic integration into the existing network environment should be included in the proposal.

Vendor must itemize all equipment and associated eligible components.

Any ineligible items must be clearly identified and separated.

Walkthroughs are by appointment only.

Vendors must request a walkthrough via email and include the associated Form 470 number in the subject line of the request email.
