Narrative
Although it says licenses are included with the switches, I also put them under Switches and Necessary Software and Licenses by themselves to be certain they are covered. There is only a need for 14 licenses and 14 switches. Please see RFP for complete details/quantities. For the total of 15 stacking cables, I put them under cabling all together even though there were two different sizes needed. Please see RFP for complete details/quantities. We are asking for a quantity of 17 power supplies, but I put them under both Antennas, Connectors, and Related Components as well as Uninterruptable Power Supply/Battery Backup and Necessary Software and Licenses because I was not certain which function they would be covered under. Please see RFP for complete details/quantities. I put the 4 SFPs under Antennas, Connectors, and Related Components. I wasn't sure where rack mounting kits should go so I put them under racks.

We need 4 UPSs, but the specifications needed are not all the same. Please see RFP for complete details/quantities.

Disqualifying Factors:

All hardware quoted must be compatible with existing infrastructure. If the equipment is different from what is requested, documentation must be provided with the proposal demonstrating that the proposed equipment is equivalent, or the proposal will not be considered.

Hardware quoted must be new with the manufacturers warranty (minimum of three years). Quotes for used equipment will not be considered.

We will not take partial quotes, meaning that we will not work with multiple vendors for this one project.

The vendor must have a SPIN at the time of awarding the contract.

Vendor must give assurances that all quoted prices will be honored at the time of purchase.

Installation costs must be listed separately from hardware costs.

In-state or local vendors are preferred.

Previous experience with vendor preferred.

SPAM and/or robotic responses will not be considered valid bid responses and will be disqualified from consideration.

The deadline for vendor proposals is 9am EST, 29 days from the date this 470 is posted. We reserve the right to reject late-submitted proposals.
