Currently, we have a fully lit fiber network, WAN connectivity to all 8 locations, and 2 primary EDI (internet) hubs that provide internet access to all 8 locations. The equipment must be compatible with all existing network infrastructure/devices which are made up of Cisco 2960, Meraki MS250-48FP and Meraki MX95 .  
 We are seeking 16 devices, 2 per location (locations shown below). We do reserve the right to purchase fewer units than the total. We are also looking for PoE capabilities with minimum of 750W per device with the ability to add additional power supply if needed.
