Narrative
Crooksville Exempted Village Schools is seeking proposals for the installation of (24) total CAT6 network cabling runs to support four new classrooms. Each classroom will receive six dedicated drops, with no individual run exceeding 328 feet. Within each room, the cabling must be distributed across four specific locations: two separate wall plates (Teacher A and Teacher B) each containing two RJ-45 CAT6 keystone jacks, one wall plate with a single keystone jack positioned behind the interactive board, and one final run terminated with an RJ-45 connector located above the ceiling in the center of the room for a wireless access point installation. Additionally, we are seeking the cost of (4) new Cisco Meraki Wireless APs (Meraki CW-9166I-MR or equivalent) and all necessary licensing for these same (4) classrooms for a term of (4) years to be co-termed with existing agreement. Proposals should also include the cost of all installation for cabling, terminations, installation of WAPs as well as Managed Internal Broadband Services for these (4) additional wireless access points.
