Proposals must be received by October 20, 2026, at 2:00 PM EST.

For all products and services requested, vendors should consider equivalent, more or less in quantity, better, and/or more cost-effective solutions consistent with the RFP requirements. Proposed equivalents must provide complete licensing and support for the identified equipment without requiring hardware replacement, loss of functionality, service disruption, unpriced products or services, or additional District cost.

All purchases are subject to applicable District and state procurement requirements and E-Rate rules. E-Rate purchases may be contingent upon USAC funding and written District authorization. Pricing must comply with the Lowest Corresponding Price rule. Vendors must separately identify E-Rate eligible and ineligible products/services and provide reasonable cost allocation when required.
