### Summary of the HCP's requested services. :

The Ninilchik Community Clinic is seeking bids to provide dedicated internet access at our rural health clinic. The anticipated application and use of the supported connection include moderate to heavy usage levels for interactive activities such as distance learning, training, real time patient examination and consultations, and video conferencing. Moderate to heavy usage for transactional needs will include distance learning, electronic patient billing and support for

electronic health records. The connection must support light to moderate transmission of large files for X-Ray images and electronic health information exchanges. The supported connection will also support electronic billing and the exchange of electronic health records. Backup and redundancy connectivity will be 24/7 and we are seeking a type of Service Level Agreement that provides near constant service availability and response. The Ninilchik Community Clinic requires Dedicated Services and not Best#Effort Services.
