Summary of the HCP's requested services. :

Medical Grade Networks and Medical Clouds are mission-critical environments designed to be resilient, highly available, and hardened. Their purpose is to provide secure transport and connectivity among eligible Healthcare Providers (HCPs), partners, and information resources (including Electronic Health Records and other clinical or operational content) necessary to support the delivery of healthcare services within the communities served. Respondents shall propose a transport solution (e.g., MPLS or other comparable technologies). All functionally equivalent transport options will be considered. Preferred solutions are carrier-class services that are dedicated and symmetric, rather than best-effort or asymmetric. Intentions are to maintain existing circuits while retaining the flexibility to upgrade broadband connections during the term of the contract. At minimum, vendors are requested to provide pricing for the following transport speeds: 10 Mbps, 20 Mbps, 25 Mbps, 50 Mbps, 75Mbps, 100 Mbps, 150 Mbps, 200 Mbps, 250 Mbps, 300 Mbps, 400 Mbps, 500 Mbps, and 1 Gbps. For Internet, the speed shall be between 8 and 1000mpbs. Any speed within the ranges being sought may be proposed. The request for pricing at these specified speeds does not limit upgrades at only those speeds. When an upgrade is required, pricing for bandwidth levels not listed (e.g., 125 Mbps) may be sought so long as the bandwidth level falls within the range requested. The purpose of this request is to obtain standardized pricing to support informed, cost-effective decisions regarding potential broadband upgrades during the contract term. Requests for site and service substitutions shall be allowed in accordance with program rules. This provision allows for site and upgrade or change service options throughout the length of the contract. Please include clearly defined service level agreements (SLAs) with measurable performance metrics and non-performance remedies. No preference is given to any specific carrier, provider, or technology. The "A" location for all proposed services shall be the eligible HCP where the circuit originates, Togiak Subregional (11008) . The "Z" location shall be a Medical Cloud or another location that enables connectivity into the existing network, including another applicant-operated HCP or facility in Togiak, AK or the surrounding area. All proposed services should be fully operational no later than July 1, 2026. Requests for extensions or exceptions to this request for service shall not be provided. Respondents must include sample or draft service agreements, and SLAs sufficient to allow timely review and evaluation. All proposals must comply with the FCC Rural Health Care (RHC) Telecom Program rules and all applicable federal and state laws and regulations.
